There are a total of 1125 tickets available; 300, 3-packs for \$50 each (750 tickets), and 375 single tickets for \$20 each. The number of tickets for sale, 1125, will not change.

There is 1 grand prize to be won. Retail value of the grand prize is \$7,300.00 and is based on the Suggested Retail Price as provided by our corporate donors at time of quoting, and includes related taxes.

The grand prize draw is at 4:30 PM on Tuesday, August 15, 2017 at the BMO Theatre Centre, 162 West 1st Avenue, Vancouver, BC V5Y0H6

DRAW INFORMATION:

Prizes are drawn manually from a container. Chances are 1 in 1125 to win the grand prize.

Prizes are tax free to Canadian residents. The cost of tickets is not tax deductible.

Winner will be published on <http://artsclub.com/events/arts-club-raffle> shortly after the final draw date.

Winner is responsible for cost of shipping or delivery.

All sales are final once ticket number is assigned, subject to credit approval.

Licensee reserves discretionary right not to accept entries.

Purchaser is responsible for proof of ownership of shared tickets.

Prize is given as awarded, no substitutions. Prize is subjected to availability and restrictions.

Prize may not be exactly as shown.

Winner consents to the release of their name, address and photo by the licensee.

Winner will be notified by phone and/or email by the Arts Club Theatre Company. Winners have 1 month from draw date to claim their prize.

ELIGIBILITY: The following people are not permitted to purchase tickets in this lottery: sellers of the Arts Club Theatre Company raffle tickets, the Submitter, the Contact Person, and the Member of the Organization responsible for the Gaming Event. A non-resident of British Columbia may purchase a ticket only if the entire payment transaction takes place while the person is in British Columbia and if the ticket or a receipt is issued at that time.

Tickets or receipts will not be distributed to, emailed or otherwise sent to a non-resident's third-party address in B.C.

We do not rent, sell, or trade our mailing lists. Information provided through ticket purchase will be used to deliver services and keep you informed on the Arts Club Theatre Company activities, including programs, services, and special events, funding needs, opportunities to volunteer or give and more, through periodic contacts.

FREQUENTLY ASKED QUESTIONS:

How many tickets are being sold?

There are 1125 tickets available for sale.

How much do tickets cost?

Tickets are 1 for \$20, 3 for \$50.

How can I obtain a winner's list?

Database of all winners is available on <http://artsclub.com/events/arts-club-raffle>.

What are the odds of winning?

Chances are 1 in 1125 to win the grand prize. All inquiries, if any, on the odds of winning, are to be made to the licensee prior to the purchase of ticket(s).

How old do you have to be to purchase a ticket?

Minors are not eligible to purchase tickets unless they are 13 years or older, and accompanied by an adult who is the minor's parent or guardian and who consents to the sale. However, some prizes require the redeemer of the prize to be over the legal age of majority of the location of redemption. (Canada - 19 years old and over; United States of America - 21 years old and over).

Can I purchase tickets if I am not a resident of British Columbia?

Yes, but there are certain restrictions and conditions, which must be met. The lottery is intended for BC residents. Ticket buyers must be in British Columbia at the time of purchase. A non-resident of British Columbia may purchase a ticket if the entire payment transaction takes place while the person is in British Columbia and if the ticket or a receipt is issued at that time. Tickets or receipts cannot be distributed to, mailed or otherwise sent to a non-residents third-party address in British Columbia.

How many prizes will be awarded?

1 grand prize will be awarded.

What is the total prize value?

Approximately \$7,300.00 based on MSRP as provided by our suppliers and includes related taxes.

Is my ticket purchase tax deductible?

No, raffle tickets are not tax deductible; even though proceeds support a charitable cause.

Where do the proceeds from the Arts Club Theatre Company Raffle go?

The proceeds from the raffle directly support staging and developing stimulating quality theatre for the enrichment of our community.

What if I lose my ticket?

You do not need your ticket to claim your prize. Your name, address, phone number, and email are recorded in the database along with your ticket number. Proof of identification will be required.

Do I have to pay tax on any winnings?

Raffle winnings are considered a windfall and not taxable in Canada.

Can I request a specific ticket number?

No. Ticket numbers are pre-assigned.

Can I purchase tickets in multiple names?

Yes, although one person will be designated as the primary purchaser and will be responsible for distributing the winnings between the multiple purchasers.

How long do I have to claim my prize?

Prizes must be claimed within one month of the draw.

How will I know if I have won a prize?

The primary ticket purchaser will be notified by phone and/or e-mail by the Arts Club Theatre Company as to what they have won and where/how to claim their prize.

RESTRICTIONS ON THE GRAND PRIZE:
